ALL ONE DAY LICENSES MUST BE ISSUED TO **THREE (3) PEOPLE** BELONGING TO THE NON-PROFIT ORGANIZATION, CLUB, SOCIETY OR ASSOCIATION (NO EXCEPTIONS).

MUST CONTAIN THE FOLLOWING INFORMATION:

ALL ONE DAY LICENSE APPLICATIONS MUST BE BROUGHT INTO THE OFFICE OF THE BOARD OF LICENSE COMMISSIONERS, 2660 RIVA RD, ANNAPOLIS, MARYLAND, FOR PROCESSING AT LEAST **ONE (1) WEEK IN ADVANCE** OF THE EVENT. OUR HOURS FOR PROCESSING APPLICATIONS ARE BETWEEN **9:00 A.M. AND 3:00 P.M.**, MONDAY THROUGH FRIDAY.

ALL FEES MUST BE IN THE FORM OF A **CHECK OR MONEY ORDER, NO CASH WILL BE ACCEPTED!!!** THE FEES ARE AS FOLLOWS: CLASS C (BEER, WINE) IS \$25.00 AND CLASS C (BEER, WINE,LIQUOR) IS \$50.00, made payable to: **A.A.Co. Liquor Board.**

A ONE-DAY LICENSE MAY ONLY BE GRANTED TO A NON-PROFIT ORGANIZATION OR NOT FOR PROFIT EVENTS.

IF THE HALL YOU ARE RENTING HOLDS A CLASS "C" LICENSE, THE RENTERS ARE NOT ALLOWED TO USE OR PURCHASE THE ALCOHOLIC BEVERAGES FROM THE CLUB/HALL. THOSE BEVERAGES ARE FOR THEIR CLUB MEMBERS ONLY. IF THE HALL DOES USE THEIR ALCOHOLIC BEVERAGES FOR A RENTAL, THEY ARE PUTTING THEIR ALCOHOLIC BEVERAGE LICENSE IN JEOPARDY OF BEING SUSPENDED AND/OR REVOKED.
